Fire Plans Review and Inspections Fee

New fee schedule goes into effect May 8th, 2024.

Fire plans review and inspections fees will be collected by the City of Sanibel.

Building Construction (New & Existing)	1/4 of 1% or \$100 Minimum
Sprinkler System - Single Family	1% or \$100 Minimum
Sprinkler System - Multi Family & Commercial	1% or \$125 Minimum
Fire Alarm System	1% or \$125 Minimum
Automatic Extinguishing Systems	1% or \$125 Minimum
LPG Permits	1% or \$100 Minimum
Development Order and/or Site Plan Review	\$100 per review
Hood Suppression System	1% or \$100 Minimum
Cooking Hood System	1% or \$100 Minimum
Temporary Tent Permits	\$75.00
Plans Review Revision	\$50.00
